THE COLOR OF DEATH IS PURPLE

In the Netherlands, the country where I live, we currently have a government consisting of three parties. Mrs. Borst told a story how she knew two women of age, "they were bored stiff, unfortunately not bored to death", she said about the women. Only a few days after a euthanasia bill passed the parliament, she wanted to go steps further. And although she said that she was sorry if she hurted anybody, days later she gets interviewed by the magazine of her own party, the D'66. In this interview she is asked what she thinks about the fact that some Christian circles find her the devil. She liked it apparently, because her answer was: "Yeah, interview with the devil, that's a good title for this interview."
